▶ Recommended Educational Loan Amount

NPR 65 – 70 Lakhs

Postgraduate (PG)
NPR 75 – 80 Lakhs

PG with Dependent
NPR 1.10 Crore

▶ Marriage Policy

- Spouse must hold **equivalent qualification**
- Marriage should be at **least 1 year old**

▶ Educational Loan & Savings

- Loans accepted from all banks **except Prabhu Bank**
- **Minimum 6 months** savings history required
- **1-year-old Fixed Deposit & B-Class** bank savings accepted
- **Extra NPR 10–15 Lakhs** strengthens profile

Eligible Sponsors

Parents | Parents-in-Law | Spouse | Grandparents| Aunt / Uncle | Siblings
Cousins **not accepted**

Sponsor Restriction: Grandparents or Aunt/Uncle cannot be sole sponsors if income is pension-based.

Accepted Documents & Sources

- Tax clearance: 2–3 years required
- Bank statement: 12 months required
- Residential rental income accepted (**up to 40%**)
- Commercial rental income accepted with 12-month bank statement
- Business income accepted with 6–12 months statements
- Class A, B & C bank statements accepted
